PERMIT APPLICATION

- Incorporation or LLC documents from the office of the Oklahoma Secretary of State if the business ownership is in the name of a corporation or LLC.
- A copy of the Oklahoma Tax Commission Sales Tax Permit.
- A copy of the current, valid certificates required by the State of Oklahoma Health Department.
- A copy of the Noble County, State of Oklahoma Health Department food handler's permit for those persons preparing and/or serving food from the food truck.
- A copy of your valid Oklahoma driver's license and for each approved driver.
- A copy of the mobile food truck's valid registration with the Oklahoma Department of Motor Vehicles. All trucks must be registered in the State of Oklahoma.
- A copy of automobile insurance for the mobile food truck, providing insurance coverage for any automobile accident that may occur while driving on the road.
- Color photographs of the front, back and both sides of the food truck showing current graphics on the food truck. Graphic photographs must be re-submitted if changed before the food truck is placed into service.
